



## STANDARD AND PERSONALIZED ELECTRIC VEHICLE LICENSE PLATES NRS 482.3797

Standard and personalized Electric Vehicle license plates may be issued for passenger vehicles, light commercial vehicles, and motorcycles that are wholly powered by an electric motor. **Electric Vehicle license plates will not be issued to other alternative fuel vehicles, such as Gasoline/Electric Hybrid, Flex Fuel, Diesel, CNG, Propane, and/or Hydrogen powered or fuel cell vehicles.**

### **Standard Electric Vehicle license plates may be issued for a fee as follows:**

\$123.00 (passenger, light commercial vehicles, and motorcycles plus a \$0.50 cent per plate Prison Industry fee. *Fees are in addition to all other registration fees and governmental services taxes.*

### **Personalized Electric Vehicle license plates may be issued for a fee as follows:**

\$158.00 (passenger, light commercial vehicles, and motorcycles plus a \$0.50 cent per plate Prison Industry fee. *Fees are in addition to all other registration fees and governmental services taxes.*

The fee to duplicate a currently registered personalized plate in the Electric Vehicle plate style is \$10, plus a \$.50 cent per plate Prison Industry fee in addition to all other registration fees and governmental services taxes.

The renewal fee for a standard Electric Vehicle license plate is \$79.00. The renewal fee for a personalized Electric Vehicle license plate is \$99.00. *Fees are in addition to all other registration fees and governmental services taxes.*

If your vehicle is currently registered, you have the option of maintaining your current registration expiration date or renewing for a full 12-month period at the time you receive your Electric Vehicle license plates. Credit for the unused portion of your current registration will be applied to your renewal. You must appear in person and surrender your current license plates to the Department to transfer this credit. You must present Nevada evidence of insurance when you visit the DMV.

**NOTE:** The Department has the right to refuse any combination of letters and/or numbers that may carry connotations offensive to good taste and decency, or which would be misleading, or in conflict with any license plate series that has been issued. **(NRS 482.3667 and NAC 482.320)**
