



## Affidavit for Bonded Vehicle Title

### Bond Information

If an applicant who is seeking a certificate of title to a vehicle from the Department and is unable to satisfy the Department that the applicant is entitled to a certificate of title, the applicant may obtain a new certificate of title from the Department by:

1. Filing a bond with the Department.
2. Allowing the Department to inspect the vehicle to verify the vehicle identification number and identification numbers, if any, on parts used to repair the vehicle; and
3. Authorizing the Department to conduct a search of the history of the vehicle through any national crime information system, including, without limitation, the:
  - a. National Crime Information Center, as defined in NRS 179A.061; and
  - b. National Motor Vehicle Title Information System of the United States Department of Justice.
4. The bond must be:
  - a. Purchased for a three (3) year period.
  - b. Executed by the applicant as principal and by a corporation qualified under the laws of this State as surety.
  - c. In an amount equal to one and one-half times the value of the vehicle, as determined by the Department; and
  - d. Conditioned to indemnify any:
    - (1) Prior owner or lienholder of the vehicle, and his or her successors in interest.
    - (2) Subsequent purchaser of the vehicle, and his or her successors in interest; or
    - (3) Person acquiring a security interest in the vehicle and his or her successors in interest, against any expense, loss or damage because of the issuance of the certificate of title or because of any defect in or undisclosed security interest in the applicant's right or title to the vehicle or the applicant's interest in the vehicle.
5. The applicant must be a Nevada Resident.
6. The vehicle must be present in Nevada.

### Steps to Obtain Bonded Title

The Title Research Section in Carson City process all bonded title requests. Mail all required documents to the Department's, Title Research Section in Carson City.

Following the steps listed below will ensure all requirements are completed.

**Do Not** purchase a bond prior to receiving documentation from the Department authorizing the bonded title and the bond amount required.

#### Step

1. Contact the Department's Title Research Section, in Carson City, (775) 684-4810.
2. Complete parts 1 and 2 of the Affidavit for Bonded Title.
3. Send the Affidavit for Bonded Title, copies of all ownership documents and 4 photographs (front, back, and sides of the vehicle) to the Title Research Section.
4. The Department will conduct a vehicle theft and brand history search.
5. The Department will calculate the bond amount based on the original Manufacturer's Retail Price (MRP).
6. The Department will return the documentation listing, bond amount and any additional requirements.
7. Obtain the appropriate bond required and complete the Affidavit for Bonded Title.
8. Complete all areas in full, either typed or printed in ink.
9. Notarization or witnessed by an authorized Nevada DMV representative is required for the document.
10. Return all **original** documentation and fees to the Department's, Title Research Section in Carson City.
