Approval of December 18th, 2020 Meeting Minutes

Discussion on meeting minutes

- Dick Mills (Wreckers); Questions statement that DMV has no jurisdiction over internet car sales
- JD Decker (DMV/CED); States that it is correct: DMV has no jurisdiction over internet car sales

Meeting Minutes approved unanimously

Review of Proposed Bills through the Legislation as the Relate to the Board

Discussion on Senate Bill 29 authorizing agents through the DMV to issue salvage titles

- Dick Mills (Wrecker); questions whether it is open to anyone
- JD Decker (DMV/CED) States that this is sponsored by the DMV
 - Part of the DMV transformation process
 - Third party vendors would contract
 - Too early in the process to have all the answers

Discussion on Senate Bill 58

- Dick Mills (Wrecker); reorganizes the Department of Public Safety
- JD Decker (DMV/CED); DPS is a different agency. Bill does not apply to DMV

Discussion on Senate Bill 60 governing vehicles

- JD Decker (DMV/CED); SB60 is a DMV clean-up bill
 - Clarifies distribution of pollution control accounts between Clark and Washoe county

- Allows private party sales three days of use before needing a moving permit

Discussion on Assembly Bill 114

- JD Decker (DMV/CED); Calls it the Tesla Exemption Bill
 - Tesla was exempt from dealer licensing through Governor's Office of Economic Development
 - Exemption is requested by other EV manufacturers through AB 114
 - DMV position is neutral on the bill
- Steve Yarborough (Garages); Questions if that would mean that all gasless manufacturers would be exempt from requiring a dealer license and therefore the DMV/CED would have no jurisdiction over them
- JD Decker (DMV/CED): Agrees that would be correct
- Steve Yarborough (Garages); States that the Board should be against bill

Update on Internet Sales that take place in the State of Nevada

Dick Mills, (Wrecker); States there is more internet sales advertising. Questions who is collecting sales tax on these sales

JD Decker, (DMV/CED):

- DMV works with Taxation, so sales tax is not an issue
- Currently there are few complaints
- Issue with internet sales is consumer protection

Vote to Support or Oppose any of the reviewed Proposed Legislation

Steve Yarborough (Garages); On AB114

- Makes motion to include language that any manufacturer, lessor, or internet sales company must comply with regulations as a licensed dealer

Vote to oppose AB114 that allows any manufacturer to sell vehicles without a dealer license

Review on the Status of Clean Energy Vehicles

Kristi Kandel (Public); Questions how much the Board and Nevada works with EV or hydrogen vehicles

JD Decker (DMV/CED); The Board does not work on the project, but has input

- The IM committee works with Nevada Division of Environmental Protection works more directly with that.
- NDEP is pursuing a clean cars bill similar to California

Kristi Kandel (Public); The Biden administration is coming out with a zero emissions initiative that is similar to the California zero emissions mandate on new cars by 2035.

1) Morgan Friend (DMV/CED) provided the following reporting statistics:

- a) Automotive Affairs Advisory Board (AAAB) Report on Body Shops
 - From July 1, 2020 through February 22, 2021 there were a total of 101 cases.
 - There were 48 cases found to be in compliance.
 - There were 8 cases found to be unsubstantiated.
 - There were 17 cases that the Department took action on.
 - There was 4 cases that the Department listed as "Other".
 - There were 24 cases that resulted in the Department referring to a master case, the Department referring the case out, Department tracking or the company being out of business.

- b) AAAB Report on Dealers
 - From July 1, 2020 through February 22, 2021 there were a total of 683 cases.
 - There were 253 cases found to be in compliance.
 - There were 53 cases found to be unsubstantiated.
 - There were 146 cases that the Department took action on.
 - There was 13 cases that the Department listed as "Other".
 - There were 218 cases that resulted in the Department referring to a master case, the Department referring the case out, Department tracking or the company being out of business.

- c) AAAB Report on Emissions
 - From July 1, 2020 through February 22, 2021 there were a total of 302 cases. Of the 302 cases, 12 were opened due to consumer complaints and 290 were opened due to Emission Station Covert Audits.
 - There were 242 cases found to be in compliance.
 - There were 6 cases found to be unsubstantiated.
 - There were 21 cases that the Department took action on.
 - There was 33 cases that the Department listed as "Other".

- d) AAAB Report on Garages
 - From July 1, 2020 through February 22, 2021 there were a total of 392 cases.
 - There were 194 cases found to be in compliance.
 - There were 15 cases found to be unsubstantiated.
 - There were 54 cases that the Department took action on.
 - There was 6 cases that the Department listed as "Other".
 - There were 123 cases that resulted in the Department referring to a master case, the Department referring the case out, Department tracking or the company being out of business.

- e) AAAB Report on Other Licensees
 - From July 1, 2020 through February 22, 2021 there were a total of 83 cases.
 - There were 15 cases found to be in compliance.
 - There was 3 case found to be unsubstantiated.
 - There were 13 cases that the Department took action on.
 - There was 3 cases that the Department listed as "Other".

- There were 49 cases that resulted in the Department referring the case out, Department tracking or the company being out of business.
- f) AAAB Report on Salvage Pools
- From July 1, 2020 through February 22, 2021 there were no cases to report.
- g) AAAB Report on Wreckers
- From July 1, 2020 through February 22, 2021 there were a total of 13 cases.
 - There were 7 cases found to be in compliance.
 - There were 6 cases that resulted in the Department referring the case out or the company being out of business.
